Business came to a standstill at Mundika market in Busia County when a couple used a handcart and a bicycle as a mode of transport to Mundika Catholic church where they took their marriage vows.

Clad in a wedding gown, the bride and the bridegroom boarded a handcart as the best maid and best man rode on a bicycle as they travelled to the church to solemnise the marriage in a mass weeding that attracted more than 100 couples.

Caroline Night and Godfrey Amin, who were being transported on the hand cart from their Esikulu village home, 4 kilometres away, ing at the church as people from Mundika market followed them to witness the rare show

With motorcycles as outriders, the bride and bridegroom snaked through the market as a huge crowd followed them to witness the grand occasion.

For the other couples who had also used bicycles as a means of transport to church, their ultimate aim was to formalise their mar-

Mundika Catholic Church parish priest, Father Maurice Langiri, who presided over the

mass wedding said that the church was out to encourage people to wed at a minimum cost as most faithful had not formalised their mar-

A major challenge to solemnising marriage in the church was polygamy, the priest said, adding that the church recognised the first wife as she was considered as the family's foundation.

The Catholic prelate criticised polygamy, saying it causes family rifts which are usually extended to the church and asked men to marry one wife and remain faithful until death -KNA


